## Strike price for the “March 2008” warrants

The strike price for the Altamir Amboise “March 2008” warrants is **€6**, corresponding to the share par value<sup>1</sup>, in accordance with the exercise conditions presented in the prospectus, which was approved by the AMF on 18 January 2007 under number 07-20.

These warrants can be exercised from **Monday 17 to Friday 21 March 2008 included**, based on 17.816 new shares for 3 warrants.

Since the stock market is closed on 21 March, transactions on the warrants (purchases/sales) will end on 20 March.
