

## Half-year review of Altamir's liquidity agreement

**Paris, 4 July 2017** – Under Altamir's liquidity agreement with ODDO BHF, the liquidity account at 30 June 2017 contained the following:

- **19,945** shares
- **479,850** euros.

For reference, the liquidity account at 31 December 2016 contained the following:

- **16,632** shares
- **513,540** euros.
