

## FDE buys back some of its share issued capital via its buy-back program

**Pontpierre, France, June 18<sup>th</sup>, 2024** - FDE (Euronext: FDE - ISIN: FR0013030152), a carbon negative energy producer, announces that it has bought back during the period of 10<sup>th</sup> June to 14<sup>th</sup> June 2024, 6,727 of its shares.

FDE continues the implementation of the share buyback program following the delegation of authority adopted by the Annual General Meeting of Shareholders of November 30<sup>th</sup>, 2023.
