Oxurion ontving een transparantiekennisgeving op 27 maart 2025 van Atlas Special Opportunities II LLC waaruit blijkt dat het op 20 maart, 2025 52.489 aandelen van de toen uitstaande 3.638.344 aandelen bezat en dus onder de drempel (3%) kwam door de verkoop van stemrechtverlenende effecten.

Oxurion ontving een transparantiekennisgeving op 27 maart 2025 van Atlas Special Opportunities II LLC waaruit blijkt dat het op 24 maart, 2025 1.007.463 aandelen van de toen uitstaande 4.634.663 aandelen bezat en dus boven de drempel (20%) kwam door de aankoop van stemrechtverlenende effecten.


